Absolute Awaken recognizes the importance and is committed to protecting the privacy and security of visitors to Absolute Awaken® website, or in person. Our privacy policy is created to demonstrate our commitment to privacy. This Policy applies to all the data we collect about you, including information collected at events, in person and information collected on any Absolute Awaken® websites (including mobile access); all of which are referred to as the "Site" in this policy. Outlined below is the Absolute Awaken online privacy policy. If you have questions about our Policy, please email AbsoluteAwaken@gmail.com and we will get you the answers to your questions.

Information Collected and Stored Automatically

When you visit Absolute Awaken, we may collect, store and/or process some or all of the following information obtained through Absolute Awaken sites or the device you are using: Location information (including GPS signals sent by a mobile device, location information gathered from social media networks or sensor or IP address data from your device;) Information from cookies, web beacons or from the internet, including your IP address, browser type, operating system, domain name, access times, which pages you visit within our Site and referring website addresses. If you ask us to connect with other sites (for example if you ask us to connect with your Facebook account) we may get information that way too.

This information is used to measure the number of visitors to the various sections of our site and identify system performance or problem areas. We also use this information to help us develop the site, analyze patterns of usage, and to make the site more useful. This information is not used for associating search terms or patterns of site navigation with individual users. Absolute Awaken periodically deletes its Web logs. On occasion, Absolute Awaken may provide this information to third party entities it contracts with for the purposes of research analysis. However, we never sell any information to third party entities.

Most of the information we collect is information provided directly by you. This may include: Contact information (information such as name, job title, company name, department, email address, physical mailing address, telephone number, and other information for coaching or helping purposes). Professional information (such as your employment background, job description and related information). Transaction information (your contact information, the services you are interested in, your purchasing requirements, your financial information including credit card or other payment information) Responses to surveys (information you provide in responding to a survey on the Site, via an app or email, on the telephone or otherwise) And include any other information collected.

We may record any telephone calls and/or zoom for quality assurance and training purposes. This information is never sold or shared with outside sources, unless for legal reasons with court order.

We may use publicly accessible information to verify the information we are provided with and to manage and expand our organization. Throughout the website there may be forms to request information and purchase or obtain products and/or services. These forms typically ask for contact information, financial information, and demographic information. Information from these forms is used to deliver the information, products and/or services that you request. It may also be used to notify you of future Absolute Awaken® products, services and/or opportunities that may be of interest to you. When completing these forms, please do not supply another person's personal data to us unless we prompt you to do so and you have received that individual's consent to do so.

Cookies

When you visit websites, their web servers generate pieces of information known as cookies. Cookies are small pieces of information that are stored by your browser on your computer's hard drive.

Absolute Awaken uses per-session cookies to serve technical purposes, like providing seamless navigation and custom-tailored content through Absolute Awaken®. These cookies do not permanently record data and they are not stored on your computer's hard

drive. Absolute Awaken's session cookies are available only during an active browser session. When you close your browser, the session cookie disappears.

Absolute Awaken® also uses persistent cookies for Performance which measure number of unique visitors and how often you visit Absolute Awaken® sites and how you use them. We use this information to get a better sense of how Absolute Awaken® users engage with Absolute Awaken® site, so that users have a better experience. For example, Absolute Awaken® collect information about which of Absolute Awaken pages are most frequently visited, and by which types of users. Absolute Awaken® uses third-party cookies to help with performance. For example, the Google Analytics cookie gives Absolute Awaken® information such as your journey between pages and whether you have downloaded anything.

These various technologies are used in analyzing trends, administering Absolute Awaken® Site, tracking users' movements around Absolute Awaken® Site and to gather demographic information about our user base. We may receive reports based on the use of these technologies on an individual as well as aggregated basis. We will copy the id as proof, so there are no charge backs. This is only needed once for each name. You can do this on cam if it is clear where we can read name, date valid through, picture, and information needed for verifying stripe payment. You can also send this in an email to AbsoluteAwaken@gmail.com, which once we get it will delete the message.

For certain Absolute Awaken® users who need access to administrative privileges to carry out Absolute Awaken functions in their roles as official representatives of federal, state, local or tribal governments or certain non-governmental organizations, Absolute Awaken® collects additional information such as name, organization, job title, and business address, business telephone number, business email address, and such things that is needed for the role they are working.

Absolute Awaken® is NOT a Privacy Act System of Record. Submission of any information is voluntary, and the collection of email addresses for user accounts with administrative privileges is being done purely for the purpose of authentication.

Online Comments
