Cancellations, Reschedules

- 3.7.1 The Cancellation Policy, Client agrees that it is the Client's responsibility to notify the Coach 48 hours in advance of the scheduled meetings. When cancellation is approved more than 48 hours before you will not be charged for this cancellation. Coach will bill Client for cancellation less than 48 hours before or missed meetings. Cancellation time is counted as the time you talk to the Coach or receive a message back. You cannot cancel on Sunday's as we are closed. Coach reserves the right to bill Client for a missed or canceled meeting. Coach will attempt in good faith to reschedule the missed meeting.
- 3.7.2 Unused program hours may not be transferred. A gift for someone can be bought by one person and given to another. A gift to one person can't be gifted to a 2nd person. The gifts cannot be split to different people. Each program or gift purchased is for one person only. When you give a gift to friends and family members as a gift for someone, please contact the Coach in advance to transfer the information.
- 3.7.3 If the Client is late for an appointment, please understand that respecting following clients the session may still need to finish at the agreed time.
- 3.7.4 If you are more than 15 minutes late for our agreed start time & the Coach has not been contacted, it will be assumed the Client has cancelled. No time will be made up, as this slot cannot be resold.
- 3.7.5 If you do a No Show on a consultation you will have to have a deposit to book again each consultation. The deposit can be applied to a session or is refundable only when you show up on time, and you forfeit your deposit if you No Show again or are late. The deposit will be no less than \$100.00 and no more than the cost of a full session. Normal session we charge. However, the consultations are complementary and should not be taken advantage of.
- 3.7.6 If you cancel a consultation less than 48 hours before the event, you will also have to pay a deposit for your next consultation. As to refill the spot gets hard the closer you are to the event. The deposit will be no less than \$100.00 and no more than the cost of a full session.
- 3.7.7 If you reschedule a consultation between 48-24 hours, we will give a 1-time grace per account, then it counts as a cancellation and require a deposit to keep consultation. The deposit will be no less than \$100.00 and no more than the cost of a full session.
- 3.7.8 If you reschedule a consultation less than 24 hours before the event, you will have to pay a deposit. The deposit will be no less than \$100.00 and no more than the cost of a full session. As this close you are not allowing others to see the coach and wasting everyone's time.

Procedure

- 3.8.1 Location & Time: The time of the coaching meetings and/or location will be determined by Coach and Client based on a mutually agreed upon time and location. The location may be in-person at Absolute Awaken® LLC office, at the client's home (for special reasons), in a public meeting place (like coffee shop for special reasons), in a private zoom meeting, or on the phone (for special reasons).
 - 3.8.1.1 In person is always best, and the best location is at Absolute Awaken® LLC Headquarters located at 555 Marriott Drive, Suite 315, Nashville, TN 37214. Which is near the airport for travelers with lots of transportation ways. The office is for scheduled appointments only and will have to be escorted to the office.
 - 3.8.1.1.1 Satellite locations are also an option. As we are in large office network and when traveling can meet at one of these offices.
(Only while traveling, other times would be in zoom)
 - 3.8.1.2 In rare conditions in person can be at a private home (for special reasons). Also, will add time for travel from office to home, then back again. The rate for travel is the same as the coach's billable hour in your plan. Time is rounded up to nearest 15 minutes.
 - 3.8.1.3 In rare conditions in person can be at a public location, like a coffee or donut shop (for special reasons). Also, will add time for travel from office to home, then back again. The rate for travel is the same as the coach's billable hour in your plan. Time is rounded up to nearest 15 minutes.
 - 3.8.1.4 When in person is not possible, it's best to meet Virtual by Zoom: When you book through (<https://www.absoluteawaken.com/contact-us/booking/book-appointment/>) our booking system, you will be provided the Zoom Meeting ID Number, Password, and link to the Zoom Video Meeting right after booking the session.
 - 3.8.1.4.1 The Client agrees to have the latest Zoom version installed (<https://zoom.us/download>),
 - 3.8.1.4.2 Client needs to be in a private and quiet place for confidentiality.
 - 3.8.1.4.3 The Client agrees to be online and ready to Zoom, video chat 5 minutes prior to the selected meeting time, so that the session may begin on time.
 - 3.8.1.4.4 The client agrees to show at least chest and above at all times.
 - 3.8.1.5 In rare conditions by phone: The Client will initiate all scheduled calls and will call the Coach at (615) 933-3388 and their extension for all scheduled meetings. If the Coach will be at any other number for a scheduled call, Client will be notified prior to the scheduled appointment time. Phone calls should not be the main source, as coaching will not be as productive, as you cannot see the person. Body language is an important part of communication and is lost over the phone. Phone is better than text but should be considered last resort.
 - 3.8.1.6 Coaching is never done over text, this is the worst way for communication, as most communication is lost in text. Text should only be, I'm outside or that type of communication.
 - 3.8.1.7 Coaching is never done through email. However, information may be passed back and forth in preparation of the coaching session.

Confidentiality

- 3.9.1 This coaching relationship, as well as all information (documented or verbal) that the Client shares with the Coach as part of this relationship, is bound by the principles of confidentiality set forth in the CLCI Code of Ethics. However, please be aware that the Coach-Client relationship is not considered a legally confidential relationship (like the medical, legal, and ministry professionals) and thus communications are not subject to the protection of any legally recognized privilege.
- 3.9.2 The Coach agrees not to disclose any information pertaining to the Client without the Client's written consent. The Coach will not disclose the Client's name as a reference without the Client's consent
- 3.9.3 Confidential Information does not include information that:
 - 3.9.3.1 Was in the Coach's possession prior to its being furnished by the Client,
 - 3.9.3.2 Is generally known to the public or in the Client's industry,

- 3.9.3.3 Is obtained by the Coach from a third party, without breach of any obligation to the Client,
- 3.9.3.4 Is independently developed by the Coach without use of or reference to the Client's confidential information,
- 3.9.3.5 The Coach is required by statute, lawfully issued subpoena, or by court order to disclose,
- 3.9.3.6 Is disclosed to the Coach and as a result of such disclosure the Coach reasonably believes there to be an imminent or likely risk of danger or harm to the Client or others,
- 3.9.3.7 Involves illegal activity. The Client also acknowledges his or her continuing obligation to raise any confidentiality questions or concerns with the Coach in a timely manner.
- 3.9.3.8 If charge disputed, evidence to prove session did happen.

Release of Information

- 3.10.1 The Coach engages in training and continuing education pursuing and/or maintaining CLCI (International Coach Federation) Credentials. That process requires the names and contact information of all Clients for possible verification by CLCI. By completing a session, you agree to have only your name, contact information with your start and end dates and/or times of coaching shared with CLCI staff members and/or other parties involved in this process for the sole and necessary purpose of verifying the coaching relationship, no personal notes or information will be shared. You must decline in writing to inform you don't want to be included in this.
- 3.10.2 According to the ethics of our profession, topics may be anonymously and hypothetically shared with other coaching professionals for training, supervision, mentoring, evaluation, and for coach professional development and/or consultation purposes.

Record Retention Policy

- 3.11.1 The Client acknowledges that the Coach records all communication by means of notes, audio, video, email, and/or messages.
- 3.11.2 Absolute Awaken® keeps your personal information private, safe, and secure. We take privacy very seriously.
- 3.11.3 The Client acknowledges his/her record retention policy with respect to documents, information, and data acquired or shared during the term of the Coach-Client relationship. Such data will be maintained by the Coach in a format of the Coach's choice, secured for privacy. Current notes may be printed and/or on a secured online OneDrive server not shared with others. Termination

- 3.12.1 Either the Client or the Coach may terminate the agreement at any time with two weeks' written notice.

4.2.3 Stripe (<https://www.stripe.com/>) when paying for in person. The card must be present and inserted or tapped on machine.

General Schedule and Fees (Unless different in invoice agreement signed.)
